



Matters reported

Section 2, Accounting statements, Council Tax Support Grant

We reported in our 2015/16 audit report that other receipts of £100 had been incorrectly included in Box 2. The Authority has again incorrectly included other receipts of £31 in Box 2 for 2016/17 and has not restated the comparative figures for 2015/16.

The Authority has not taken appropriate action on all matters raised in reports from the external auditor. In our view the correct response to Assertion 7 on Section 1 of the Annual Return is "No".
